1. From the west – Travel on Highway 1 to Highway 37 (Gull Lake/Shاونавон). Go south on Highway 37 for 55 km. Turn west on Highway 13 toward Eastend. Go 13 km to Dollard and there will be a sign pointing you to trial field. Go south 1.5 km – the field will be on the west side.
2. From the south - Turn left at the junction on to HWY 13 towards Eastend . Travel 13 km to Dollard and there will be a sign pointing you to trial field. Go south about 1.5 km and the field will be on the west side.

Qualifications for the CBCA Championships

Canadian Championship Trial: All Handlers must be CBCA members in good standing for the current year, and all entered dogs must be registered with the CBCA. Membership and registration applications and payment MUST be postmarked by June 1st, 2013, to be eligible.

Canadian Championship Nursery Trial. As with the Open, all handlers must be CBCA members and entered dogs must be registered with the CBCA. Membership and registration applications and payment MUST be postmarked by June 1st, 2013, to be eligible. Nursery dog is eligible to compete if its third birthday falls on or after July 1, 20113 .

The Canadian Double Lift Finals, on August 25, will be the top 10 Canadian entries, based on the accumulated score of the two prior runs

Shaunavon Sheep Dog Trial Only

Pro Novice will be run only as part of the Shaunavon Sheep Dog Trial. For dogs and/or handlers not eligible for the CBCA Championships and/or the CBCA Nursery Championships, you may enter the Shaunavon Sheep Dog Classic Open and Nursery classes (USBCHA sanctioned). Please note that Open and Nursery payout only will be given to those in the CBCA and CBCA Nursery classes. Pro Novice payout to 4 places.

Entry Fees

Open - CBCA Championships: 2 runs @ \$100 per run

Open - Shaunavon SDT: 2 runs @ \$100 per run (enter only if you are not eligible for CBCA Championships)

Nursery - CBCA Championships: 2 runs @ \$45 per run

Nursery Shaunavon SDT: 2 runs @ \$45 per run (enter only if you are not eligible for CBCA Championships)

Pro Novice: 2 runs @ \$50 per run.
